All parties signing this application stipulate that placing an order with The Dust Patrol LLC constitutes doing business in the state of California and all matters related to this application, any extension of credit, or any invoice shall be governed by the laws of California and should any dispute arise related hereto, all parties stipulate that sole and exclusive jurisdiction and venue shall be the Superior Court, in and for Solano County, California or the United States District Court in the State of California. By execution of this application, each party accepts and agrees to the exclusive jurisdiction of the aforesaid courts and irrevocably agrees to be bound by any judgment rendered thereby. In any dispute related to this agreement the prevailing party is entitled to its attorney fees in addition to any other damages or award.

All invoices accompanying any product advanced by The Dust Patrol LLC are due and payable according to the terms listed on any invoice accompanying product. Discounts taken after the discount date will not be honored and will be charged back to the account. Returned checks will forfeit all discounts. There is a \$50.00 service charge on any returned check. All past due balances related to invoices for products advanced pursuant to this dealer application will be assessed a 10% late fee penalty plus accrued interest at the rate of 2% per month.
